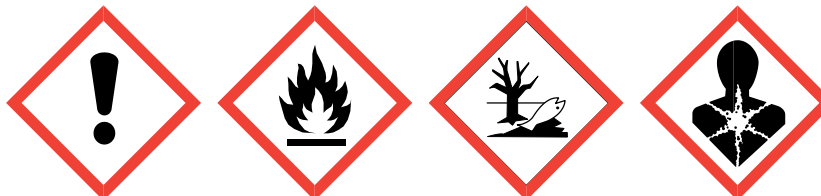

SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

General information

Remove affected person from source of contamination. Perform artificial respiration if breathing has stopped.

Inhalation

Inhalation may cause coughing, tightness of the chest and irritation of the respiratory system. Move the exposed person to fresh air at once. Get medical attention if any discomfort continues.
